- Sponsorships will not be accepted, and following acceptance, sponsor recognitions may be removed if, in the exclusive discretion of the President or Board, the reputation, activities, associations or affiliations of the sponsoring entity is or becomes contrary or detrimental to the principles, standards or objectives of TMA or to the Biblical principles by which TMA is guided.
- Preference between competing sponsorship applications may be given to Christian or not-for-profit organizations.
- TMA retains the right to remove any sponsorship recognition at any time if the President or the Board believes such removal is in the best interest of the school or if the corresponding sponsorship obligations are not paid in a timely manner. If a sponsorship recognition is removed for any reason other than non-payment, the sponsor will only be obligated to pay for the time the recognition was posted, and in such case, will receive a pro-rated refund for any pre-paid balances. Otherwise, sponsors are responsible to pay all sponsorship payments for the duration of the contract period for which you commit.
